Our Strategic Priorities



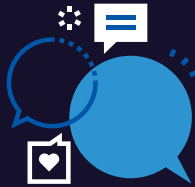
Projects

LCO projects depend on ongoing collaboration and dialogue with a broad range of individuals and organizations. Between 2022 and 2025, the LCO will:

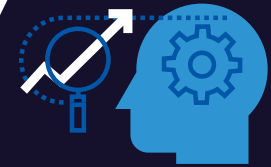
- Continue to invite input from, and engage with, individuals, organizations, and communities across Ontario.
